#### Minutes

RESOLVED that the minutes of the February 5<sup>th</sup>, 2025 meeting Environment and Energy Innovation Committee meeting be reviewed and approved.

Discussion on the motion: David Schell noted that the Peace Park is being refurbished by the Parks and Recreation Committee and Lions Club. He questioned if it is possible to have some new trees planted at the top of the toboggan hill. Adam Prouse requested that the Chair send him an email with how many are required and where

they would like to be planted and the Works Department can take care of planting. Adam noted that due to the location, the Township would be unable to provide watering like they do for roadside plantings.

#### **Business Arising from the Minutes**

#### <u>Electrical Audit Updates – Foldens, Salford and Beachville Museum</u>

Adam noted that the electrical audit for Salford is currently being completed, Beachville Museum will be next followed by Foldens Hall. Adam and Darryl spoke with the Beachville Museum Curator who noted an increase in their hydro usage.

#### **Energy Consumption Reports**

The Committee reviewed the monthly data provided for the Mount Elgin Community Centre as well as a summary of the usage at the Salford Community Centre and provided the following comments:

- Discussion regarding the potential future replacement of the gas boiler at the Mount Elgin Community Centre – consideration should be given to replace with heat pump technology (air source). Darryl to obtain quotes.
- Salford Hall energy usage fairly consistent.
- Valerie noted that in the kitchen by the stove, there is cold air coming in from the upper vent – Adam will ask Evan Swance to look into this.
- It was noted that the insulation projects and other renovations have helped to reduce energy consumption at the Salford Hall.

#### Correspondence

#### <u>UTRCA – Upper Thames River Phosphorus Reduction Program</u>

The Thames River Phosphorus Reduction Program is a new four-year program that offers incentives for cover crops, reducing tillage, 4R practices, manure management, as well as cost-share rates for a variety of practices. Incentive payment categories can be stacked. Eligible projects include:

- Cover Crops
- Reduced Tillage

- Subsurface Phosphorus Placement
- Soil Testing and Nutrient Planning
- Erosion Control
- Livestock Watercourse Fencing
- Clean Water Diversion
- Innovative Actions
- Forestry and Tree Planting

The Committee requested that this be shared in the April SWOX Talks and Village Voice publications.

- Adam hasn't heard back from EPCOR regarding a potential natural gas line for filling vehicles
- George has provided bio-fuel data to Adam didn't seem like there were any depots close enough that we could count on to utilize
